## Section 100: Srila Prabhupada

100:03: Srila Prabhupada: Guidelines

## [Title] – Celebration of Srila Prabhupada's 125th Anniversary Vyasa Puja — 2021

[Meeting] – GBC Virtual Meeting (passed on August 18, 2021) [Category] – Statement

Whereas His Divine Grace A.C. Bhaktivedanta Swami Srila Prabhupada is the Founder-Acarya of ISKCON, and his teachings and example are the guide and inspiration for the entire International Society for Krishna Consciousness:

Whereas celebration of his appearance in this world is an annual event of great significance for all ISKCON devotees throughout the world;

Whereas Srila Prabhupada's Vyasa Puja Day 2021 marks the 125th year of his appearance in this world; and

Whereas special advance events leading up to the celebration of his 2021 Vyasa Puja Anniversary were limited due to the impact of the global covid pandemic.

### **RESOLVED:**

That, the Governing Body Commission requests all ISKCON regions, temples, and communities to highlight and celebrate Srila Prabhupada's 125th Appearance Anniversary throughout the upcoming year, including Prabhupada's Vyasa Puja Day 2021 and ending with Vyasa Puja Day 2022.

The GBC is particularly grateful for the ideas, themes and programs generated by the Prabhupada 125th Anniversary Committee in India.

The GBC recommends that devotees around the world utilize the ideas the Committee has generated, including the official 125th Anniversary logo, as well as any other ideas and programs that may be locally initiated, to celebrate this historic year in a humble mood of gratitude and service to His Divine Grace.

203.04: GBC members: Individual members

### [Title] - HH Bhakti Charu Swami's Samadhi — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

Whereas HH Bhakti Charu Swami has rendered many years of exceptional service to Srila Prabhupada, Sri Dhama Mayapur, and ISKCON;

Whereas Bhakti Charu Swami is a prominent devotee whose passing should be marked by a samadhi structure over the place where his body is interred;

Whereas Bhakti Charu Swami departed from this world on the appearance day of Sanatana Goswami, Guru Purnima, July 4, 2020, and his body was interred in Mayapur, 13 July 2020, therefore, there is an urgency to finalize the samadhi structure.

### **RESOLVED:**

HH Bhakti Charu Swami shall have a samadhi structure built over the place where his body is interred.

## 203.04: GBC members: Individual members [Title] – Bhakti Charu Swami's Samadhi size exception — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

Whereas it is necessary to finalize the decision for the samadhi of Bhakti Charu Swami;

Whereas Tamal Krishna Goswami's full body samadhi in Mayapur is 2.7 metres long, (because he was put into samadhi lying down) by 1.8 metres wide, by 2.9 metres high, and this is an exceptional circumstance;

Whereas Sridhara Swami's full body samadhi in Mayapur is 1.6 metres long, by 1.7 metres wide, by 2.7 metres high;

Whereas Tatpar Swami's full body samadhi in Mayapur is 1.0 metre long, by 0.8 metre wide, by 1.6 metres high;

Whereas the standard size for samadhis in ISKCON is .9 metre (3ft) long, by .9 metre (3ft) wide maximum footprint, and 1.5 metres (4ft 11in) maximum height;

Whereas the GBC body feels it is appropriate to make an exemption to the size restriction for Bhakti Charu Swami's samadhi.

### **RESOLVED:**

That the samadhi structure for Bhakti Charu Swami will be the same size as the samadhi of Tamal Krishna Goswami — a maximum footprint of 2.7 metres by 1.8 metres, and a maximum height of 2.9 metres.

### 203.04: GBC members: Individual members

[Title] – Final decision on samadhi of HH Jayapataka Swami and further considerations regarding samadhis near Srila Prabhupada's puspa samadhi in Mayapur — 2021

[Meeting] – GBC Virtual Meeting (passed on January 6, 2021) [Category] – Statement

Whereas after repeated attempts to get clarity on what is the right course of action regarding the samadhi area near Srila Prabhupada's puspa samadhi, a conclusion has not been reached;

Whereas further attempts via surveys seem impractical and unwanted;

Whereas there are a significant number of undecided members, therefore it is difficult to get a clear picture of what the GBC wants:

Whereas the survey presented to the GBC members in December 2020 regarding more samadhis in the area near Srila Prabhupada's puspa samadhi received votes of 10 in favor, 9 against, and 9 undecided;

Whereas in 2018 there was a consensus amongst GBC members that HH Jayapataka Maharaja's samadhi will be placed in this area.

#### **RESOLVED:**

That HH Jayapataka Swami's samadhi will be in the Mayapur Samadhi Park near Srila Prabhupada's puspa samadhi. The samadhi will be no larger than the size of HH Tamal Krishna Goswami's samadhi.

There will be no further samadhis in the samadhi area near Srila Prabhupada's puspa samadhi until the matter is decided by the GBC body.

## 203.04: GBC members: Individual members [Title] – Rompada Swami's leave of absence extension — 2021

[Meeting] – Online AGM (passed on March 3, 2021) [Category] – Action Order

The Leave of Absence of Romapada Swami is extended by a further one year, to March 2022.

# 203.04: GBC members: Individual members [Title] – HH Hridayananda dasa Goswami as GBC Emeritus — 2021

[Meeting] – GBC Virtual Meeting (passed on September 22, 2021) [Category] – Statement

That in recognition of his long-standing service to the GBC Body, HH Hridayananda dasa Goswami is again hereby awarded the status of GBC Emeritus.

## 204.01 GBC meetings: Regulations

[Title] – GBC Virtual and online meetings established as General Meetings, pt. 1 — 2021

[Meeting] – Correspondence Vote (passed on January 6, 2021) [Category] – Rule of order

Whereas Article VI Clause 1 of the Regulations of the ISKCON Governing Body Commission (GBC) Society of West Bengal states that the Annual General Meeting (AGM) "shall be held during Shree Krishna Caitanya Mahaprabhu's birth anniversary celebrations at Shree Mayapur, District Nadia, West Bengal, India, unless extraordinary events make such a venue and timing impossible";

Whereas the GBC Executive Committee posits that the current Covid-19 global situation is such an "extraordinary event" whereby it is not feasible for the GBC to physically conduct its AGM in Mayapur in February-March 2021;

Whereas the above view is wholeheartedly shared by the GBC's General Counsel;

Whereas Article VI Clause 4 of the Regulations of the ISKCON GBC Society allows for a Special General Meeting to be called if an emergency exists;

Whereas pursuant to the above, the Executive Committee hereby calls for a Special General Meeting and will place as one of the agenda items the postponement of the 2021 Mayapur AGM;

Whereas the EC shall, in the Special General Meeting also propose that all resolutions passed and adopted from now till the next physical GBC meeting be conducted by Correspondence Vote pursuant to GBC Resolution 418 of 2006.

This will include voting on any matters which ordinarily would have been conducted during the AGM;

Whereas the GBC EC shall also, in the Special General Meeting, propose that the GBC Virtual Conference also become an official medium for dealing with all GBC business, including proposals and votes during the year, regardless of the holding of an AGM or not.

### **RESOLVED:**

That the GBC Annual General Meeting of 2021 is hereby postponed until further notice due to the current Covid-19 global situation. All GBC business, including voting on proposals, may be conducted either via correspondence on the GBC Discussions email conference, or online via the GBC Virtual meetings.

# 204.01 GBC meetings: Regulations [Title] – GBC Virtual and online meetings established as General Meetings pt. 2—2021

[Meeting] – Correspondence Vote (Passed on January 6, 2021) [Category] – Rule of order

Whereas the GBC conducts virtual conference meetings using online platforms, along with face-to-face plenary meetings and email correspondence voting;

Whereas proposals may be presented, voted on and made into official GBC resolutions using online platforms;

Whereas the virtual meetings are attended by GBCs, Ministers, a representative from the SABHA, a representative from the Deputies, a representative from the Executive Secretariat and others, as deemed necessary by the GBC Executive Committee.

### **RESOLVED:**

GBC virtual meetings using online systems, such as Zoom etc. are accepted as an official platform for GBC meetings.

## 204.02 GBC meetings: Agenda and schedule [Title] – Dealing with urgent matters — 2021

[Meeting] – Online AGM (passed on May 14, 2021) [Category] – Rule of order

Whereas giving a fair and timely hearing to a large group of concerned GBC members seeking to share information and engage in discussion and deliberation on a matter which they deem of great importance is not only desirable but proper.

#### **RESOLVED:**

When 33% or more of the GBC members submit a request to the Executive Committee to place a matter on the agenda of a GBC meeting for the purpose of discussion, deliberation and/or decision-making, that matter shall be taken up as an introductory presentation of no more than 30 minutes on a GBC meeting agenda to be held within 30 calendar days after submission of the request.

# 204.03 GBC Meetings: Annual General Meeting: Dates for 2022 GBC Annual General Meeting — 2021

[Meeting] – GBC Virtual Meeting (passed on November 24, 2021) [Category] – Action Order

#### **RESOLVED:**

Due to the ongoing Covid-19 crisis, the 2022 Annual General Meeting of the ISKCON Governing Body Society shall be held online

## 206.01: GBC proposals, resolutions and voting: Voting

## [Title] - Rules for voting online - 2021

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Rule of order

#### Part A

Whereas the sequential and ordered processing of proposals has been codified and can be managed easily in the GEM software;

Whereas processes usually managed in face-to-face meetings are replicated, streamlined and stored securely in the GEM;

Whereas proposal processing and voting can be readily captured and calculated online making it easy for the GBC EC, Deputies, OrgDev, SABHA and secretaries to keep track of all stages of proposal management;

Whereas comments can be quickly tabulated and incorporated into PMIs, presentations and proposals as necessary.

#### **RESOLVED:**

That the online GBC Environment for Meetings (GEM) shall be an official system for processing proposals and resolutions for the ISKCON GBC Society (WB).

Part B: (passed during the GBC Virtual Meeting on November 24, 2021):

Whereas the rules for GBC voting via GEM need to be clarified.

#### **RESOLVED:**

- 1. All proposals submitted to the GBC will be processed using GEM except where the GBC EC decides a different methodology is required.
- All proposals shall be lodged via the Proposals conference and processed by the Deputies. Any exemptions to the proposal process that may be in place for GBC- appointed committees shall apply to GEM voting as well
- 3. When the GBC Executive Committee decides that a proposal warrants bypassing the Deputies, due to considerations such as confidentiality or it being an emergency, etc, the proposal will be sent directly to the GBC First Review level on GEM (see Point 6 below).
- 4. When using GEM during in-person meetings, schedules will be determined by the Deputy EC and the GBC EC.
- 5. The following timeline refers to the use of GEM in a virtual setting, e.g. Zoom.
- 6. From the time the proposal reaches the GBC First Review stage on GEM, seven (7) days shall be allowed for discussion before Straw Voting.
- 7. Following this initial discussion period five (5) days will be given for Straw Voting.
- 8. At the conclusion of the Straw Vote the Deputy EC, or in special cases, the Corresponding Secretary, will distribute the results to all participants. If the proposal does not require editing, the Deputy EC (or Corresponding Secretary) will then announce the commencement of the GBC Final Review.
- 9. If editing is required, the Deputy EC (or Corresponding Secretary) Will then edit the proposal in a maximum of three (3) days, following which The GBC Final Review will commence.
- 10. A period of seven (7) days will be allowed for the GBC Final Review before the Final Vote.
- 11. If, during the GBC Final Review, a member proposes an amendment, discussion will stop. The amendment will be discussed for up to three (3) days after which it will be voted upon. The GBC Final Review will then continue.
- 12. If, during the GBC Final Review, a member proposes that discussion should take place outside GEM, and this is seconded, a vote will be taken. If there is a simple majority in favor, the discussion will then take place virtually, e.g. on Zoom. The GBC Final Review will then continue.
- 13. Following the GBC Final Review, seven (7) days will be allocated for the GBC Final Vote.
- 14. Three quarters (75%) of the eligible participants must vote for a Final Vote to be considered binding. (Eligible participants are GBC members who are not on a Leave of Absence or are not restricted from voting for disciplinary or other reasons.)
- 15. Voting requirements for the various types of proposals, of either simple majority, two-thirds majority, or three quarters majority etc, will be applied to votes as per the standard GBC Rules of Order.
- 16. If fewer than three quarters (75%) of the eligible participants have voted within seven (7) days, the GBC Executive Committee will contact those who have not voted and attempt to get their votes in a maximum of a further seven (7) days.
- 17. If, following that extended period, fewer than three quarters (75%) Of the eligible participants have voted, then the vote is void. At the discretion of the Executive Committee, the proposal may be reconsidered for additional discussion and voting via GEM, virtually, e.g. Zoom, or at the next General Meeting.
- 18. All resolutions passed on GEM are final and binding, subject to Review by the SABHA where appropriate, and Legal Review, and do not have to be further approved at either an Annual General Meeting or a Midterm General Meeting.

19. The GBC Secretariat shall keep detailed records of those who have not voted within the Final Voting period. Reasons for not voting must be submitted in writing to the Executive Committee.

# 206.02: GBC proposals, resolutions, and voting: Resolutions and proposals

### [Title] - GBC resolutions and cultural sensitivity — 2021

[Meeting] – GBC Virtual Meeting (passed on November 17, 2021) [Category] – Statement

Whereas ISKCON is a growing international society, with communities on six continents;

Whereas ISKCON members and communities naturally interact, and exist within, many different cultures, languages and historical traditions;

Whereas ISKCON is composed of devotees from a wide variety of backgrounds, races, ethnicities, traditions, and cultures;

Whereas our Founder-Acarya Srila Prabhupada stressed the need to share Krishna Consciousness according to time, place, and circumstance;

Whereas Srila Prabhupada taught us the importance of unity in diversity, and the importance of cooperation;

Whereas, the Governing Body Commission acknowledges that the varieties of cultural expressions of Krishna consciousness are a strength, not a weakness, and a symbol of our global success and expansion.

### **RESOLVED:**

- 1. The GBC Body may, on exceptional occasions, pass resolutions which may, due to differing cultural norms in certain parts of the world, require special attention, and thus the GBC may designate such a resolution as potentially a "culturally sensitive resolution."
- 2. A Regional Governing Body (RGB), or where there is no RGB, an authorized national council with the support of their GBC, or where a national council has more than one GBC, a majority of their GBCs, may apply to the GBC Body with a request to modify a culturally sensitive resolution for their area/yatra. Such a request must include the details of the specific adjustment/s they propose to make, as well as the reasons for requesting such an adjustment/s.
- 3. The GBC Body will give guidelines and set out the parameters regarding what may or may not be adjusted within a culturally sensitive resolution. Any details, guidelines, parameters, timelines, etc., in regard to its exceptional status must be recorded within the resolution itself.

# 209.03: Spiritual Advisors Bhagavat Assembly (SABHA): Membership

[Title] – Increasing the Age Limit of Youth Representatives on the SABHA — 2021

[Meeting] – Online AGM (passed via GEM on March 30, 2021) [Category] – Action order

Whereas the age limit for youth representatives assigned to the SABHA is currently 30 years of age;

Whereas discussions on the SABHA often take a high degree of maturity in knowledge, experience, and perspective;

Whereas including devotees up through the age of thirty-five offers a greater number from which to choose;

Whereas the Youth Minister says, "Extending the age to 35 will be very helpful."

### **RESOLVED:**

That GBC Resolution no.306/2018 (The SABHA — Spiritual Advisors Bhagavat Assembly) 6.I(b) (iv) be changed from "Youth (3): Devotees below the age of thirty (30) at the time of election" to "Youth (3): Devotees below the age of thirty-six (36) at the time of election."

# Section 300: International Society for Krishna Consciousness

## 301.04: ISKCON members: Reinstating a devotee's participation in ISKCON

[Title] - Reinstatement of Keshava Swami — 2021

[Meeting] – GBC Virtual Meeting (passed on October 20, 2021) [Category] – Statement

### **RESOLVED:**

Keshava Swami is hereby reinstated as an ISKCON sannyasi in good standing. His preaching and service area is limited to Latin America. He may be invited by local leaders to speak at their temples in India.

## 301.05: ISKCON members: Restricting a devotee's participation in ISKCON

## [Title] – Excommunication of Raya Nitai dasa aka Ryan DePue from ISKCON worldwide — 2021

[Meeting] – Online AGM (passed on April 7, 2021) [Category] – Statement

Whereas Raya Nitai dasa promotes Nazism, homophobia, racism, white supremacy and misogyny on various websites, Facebook pages and published materials.

Whereas Raya Nitai claims that Srila Prabhupada promoted the above in his teachings.

Whereas Raya Nitai's offensive materials misrepresent Srila Prabhupada, misrepresents ISKCON to the public and offends devotees with his rhetoric.

Whereas Raya Nitai has been told by the North American Council to stop misrepresenting ISKCON and Srila Prabhupada but refuses to do so. He claims he is not ISKCON and is truly representing Srila Prabhupada's teachings.

Whereas many devotees are offended and upset by his actions and are demanding that the GBC make a strong statement to protect ISKCON's reputation and the integrity of Srila Prabhupada and his teachings.

#### **RESOLVED:**

Raya Nitai dasa has been excommunicated as a member of ISKCON and is not representing ISKCON or Srila Prabhupada with his offensive propaganda. ISKCON does not support Nazism, white supremacy or racism by its practices or teachings

### [Footnotes to resolution]

North American Council has communicated with Raya Nitai dasa, demanded that he stop misrepresenting ISKCON and Srila Prabhupada and effectively banned him from visiting temples or attending any ISKCON events. He continues his damaging activities and in fact has escalated in his on-line forums.

A GBC Body resolution will reinforce the restrictions (world-wide ban from visiting any ISKCON centre or attending any ISKCON event).

A GBC resolution will create a public statement that can be used in counter negative publicity and devotee complaints about his activities.

### 301.06: ISKCON members: Individual devotees

## [Title] – GBC decision concerning Ananda Caitanya dasa's appeal — 2021

[Meeting] – Online AGM (passed on April 2, 2021) [Category] – Administrative order

Whereas Ananda Caitanya dasa (BCAIS) and the lady with whom he had a relationship confessed that, while he was a sannyasi, they engaged in illicit sex on a number of occasions;

Whereas Ananda Caitanya dasa, on numerous occasions, even during interviews in a formal investigation into his actions, lied concerning the allegations of his deviations as a sannyasi;

Whereas Ananda Caitanya dasa committed numerous offenses against those conducting the investigation into his actions;

Whereas Ananda Caitanya dasa violated the terms of his probation as given in GBC resolution (301.6 of 2020)

#### **RESOLVED:**

Two committees will be formed to monitor Ananda Caitanya dasa.

The first committee, an International committee, will be comprised of Bhakti Vijnana Goswami, Bhakti Caitanya Swami, Caitanya Candra Carana dasa, and Acyutatma dasa. This Committee will monitor Ananda

Caitanya dasa's general behavior and his adherence to the GBC's decision and restrictions resulting from his deviations.

The second committee, a Local committee, will be comprised of the Lithuanian national leadership headed by Dhruvananda dasa. This committee will monitor Ananda Caitanya dasa's services and adherence to the GBC resolution in Lithuania.

Ananda Caitanya dasa will remain in Lithuania under the supervision of the local leadership for a period of two years effective from the date of this resolution. Under their guidance and supervision, he will be encouraged to serve in whatever capacity they see as appropriate. In Lithuania, during the next two years effective from the date of this resolution, Ananda Caitanya dasa will not be permitted to give classes, neither in person nor online nor lead kirtans in any ISKCON temple, ISKCON centre, and/or ISKCON related organisations and/or congregations in Lithuania.

Ananda Caitanya dasa will be encouraged to serve senior devotees around the world in some non-public setting, such as translating their lectures off-line.

The Lithuanian leadership will give a semi-annual report and recommendations concerning Ananda Caitanya dasa to the International committee.

After two years, effective from the date of this resolution, the International and Local committees will decide on which restrictions in Lithuania, which include, but are not limited to, preaching and leading kirtans will continued to be imposed on Ananda Caitanya dasa.

It is suggested that the local authorities consider obtaining professional counseling to help Ananda Caitanya dasa.

GBC Resolution 301.06 of 2020, which dealt with the possible future reinstatement of Ananda Caitanya dasa as an ISKCON sannyasi, is hereby rescinded.

Outside of Lithuania, Ananda Caitanya dasa, for an indefinite period of time, effective from the date of this resolution, is not allowed to give classes, lead kirtans, either in person and/or online, or take any leadership position in any ISKCON temple, ISKCON centre, and/or ISKCON related organisations and/or congregations worldwide.

The international committee can, after a period of 3 years, effective from the date of this resolution, submit a request to the GBC that resolution be modified or rescinded.

When wearing dhoti and kurta Ananda Caitanya dasa must not dress in saffron.

Any violations by Ananda Caitanya dasa of any or all of the above restrictions will result in further disciplinary measures being imposed upon him.

# 303.03: ISKCON temples and affiliates: Guidelines for ISKCON temples

[Title] - Eco-theology and Three Tiers of Eco-Guidelines — 2021

[Meeting] - Online AGM (passed via GEM on April 10, 2021)

[Category] - Guideline

Whereas Srila Prabhupada's Sixth Purpose for ISKCON is to teach a "simpler more natural way of life;"

Whereas the ISKCON Environmental Initiative (IEI) has produced a document "The Eco-theology of Our Tradition" delineating the importance of environmental awareness and appropriate behaviors for Gaudiya Vaishnavas and the followers of Srila Prabhupada;

Whereas ISKCON communities both urban or rural should be exemplary in upholding the principles of sattvic lifestyles in all areas, including in their vision, teaching, and management;

Whereas ISKCON communities lack specific guidelines for practical steps to undertake regarding respect and care for the natural environment:

Whereas the ISKCON Global Duty Officer for the Environment, the ISKCON Environmental Initiative (IEI), and ISKCON Communications Ministry have developed appropriate guidelines in three tiers, or levels of application, for temple communities and members;

Whereas such guidelines have been reviewed and endorsed by leading members and managers of ISKCON who are concerned and knowledgeable in these issues:

Whereas care of the earth is an essential issue facing society-at-large, and there is a significant role for ISKCON to play in demonstrating care for Lord Krishna's creation;

Whereas ISKCON communities, members, and the world in general will benefit from the GBC endorsing such guidelines and encouraging their application within ISKCON.

#### **RESOLVED:**

The document "Three Tiers of Environmental Practices" as presented by the ISKCON Environmental Initiative, the ISKCON Global Duty Officer of the Environment, and the ISKCON Communications Ministry, and with the endorsement of other global ISKCON leaders and scholars, is hereby adopted as an Official Guideline for all ISKCON Temples and Communities. The GBC strongly encourages all ISKCON temples, communities, and projects, and wherever possible individual devotees, to apply the principles and guidelines in their daily lives and practices. (It is understood that these guidelines may be updated, every 3-5 years, at the discretion of the GDO of the Environment, the ISKCON Communications Ministry, and the ISKCON Environmental Initiative.)

Furthermore, the document "Eco-theology of Our Tradition" is recognized by the GBC as providing valuable insights on the Gaudiya Vaishnava philosophy regarding the need for ISKCON devotees and leaders to strive to live in harmony with the natural environment, and to respect the natural world as the property and energy of the Supreme Lord.

### [Footnotes to resolution]

Recognizing the document "Eco-theology of Our Tradition" carries no cost.

Adopting the Three Tiers of Environmental Practices as Guidelines may have some initial costs, but will have a positive short and long term economic impact on local communities.

- 1. Most Tier One guidelines, such as composting and recycling, will incur no costs. Some guidelines, such as minimizing waste of food and energy will immediately *save* money. Some items, such as stopping the use of environmentally harmful garden products and only using biodegradable plates, cups, and flatware may incur initial costs but are likely to inspire donors to cover those costs.
- 2. Some Tier Two guidelines will immediately save money, such as growing more food in temple gardens. Other items, such as purchasing energy efficient machines and automobiles, will require upfront costs that will be recovered over time, and save money in the long run.

### 301.03: ISKCON members: Guidelines

[Title] - Code of ethical behavior - 2021

[Meeting] – Online AGM (passed via GEM on August 16, 2021)

### [Category] - Statement

Whereas Srila Prabhupada wished his followers to exhibit exemplary ethical behavior;

Whereas the GBC Body seeks to encourage ISKCON devotees in such behavior;

Whereas since 1975 the GBC has created meaningful ethical guidelines;

Whereas there is a need of consolidating these guidelines into a concise document,

#### **RESOLVED:**

That the ISKCON GBC accepts the <u>Code of Ethical Behaviour</u> and the guidelines contained therein as a living document that gives guidance to devotees and provide resources to leaders and managers who are called upon to deal with issues regarding ethical behaviour.

### 307.04: ISKCON — other: General

### [Title] - ISKCON's statement on race — 2021

[Meeting] – GBC Virtual Meeting (passed on September 1, 2021) [Category] – Statement

Whereas ISKCON needs to reinforce its position on race;

#### **RESOLVED:**

That ISKCON's global Governing Body Commission (GBC) issues the following as ISKCON's official position statement on race:

In this time of global strife, tension, and polarization, the insights expressed in the Bhagavad Gita, a timeless wisdom text, irrevocably establish the spiritual equality of all beings. Such equality fosters tolerance, understanding, deep compassion, and unity in diversity. Moreover, Sri Isopanisad says, "He who systematically sees everything in relation to the Supreme Lord, who sees all living entities as His parts and parcels, and who sees the Supreme Lord within everything never hates anything or any being." In this way, all living beings are souls, children of God, brothers and sisters in God's all-embracing family.

In the Gaudiya Vaishnava tradition, of which the International Society for Krishna Consciousness (ISKCON) is a present-day branch, inclusiveness has been taught by generations of teachers, including Sri Caitanya Mahaprabhu (1486-1534), the pioneer of a great social and religious movement that began five centuries ago in India. Despite forceful opposition, Sri Caitanya Mahaprabhu, who is understood by the tradition to be Lord Krishna (God) Himself, opened his movement to everyone.

In turn, His Divine Grace A. C. Bhaktivedanta Swami Prabhupada, (1896–1977), ISKCON's Founder-Acharya, travelled the world to establish ISKCON and spread the message of bhakti, or unconditional love of God, and to teach that spiritually we are all equal. Hence, Sri Caitanya's vision of equality and inclusiveness underpins ISKCON's worldview.

Srila Prabhupada tirelessly proclaimed the physical body to be like an outward dress and the spirit soul to be the real person. He taught that material differences were external and superficial. What matters is the person, not the dress — the soul, not the body. On the spiritual plane of the soul, equality is true and absolute. In this way, his teachings pivoted on spirit, not matter. They went far

beyond the considerations of body, mind, intellect, and false ego to culminate in pure devotion and service to God, which only begins in earnest when our sense of who we are is firmly removed from any bodily, psychological, or intellectual designation.

Through his prolific writings, lectures, and organizational designs, Srila Prabhupada tirelessly endeavored to assist everyone in rekindling this vision and their natural love and in refining the kindness, integrity, and happiness that ensue. He placed love and compassion at the center of his personal dealings, and he exemplified these divine qualities in the way he inspired and directed the communities and organizations he founded. He taught that traits such as sex, race, and social class are ultimately irrelevant. His efforts were heroic; his accomplishments profound.

Clearly, such a sublime, spiritual vision warmly embraces all communities and races. Indeed, ISKCON, or the Hare Krishna movement, is committed to this vision and therefore invites everyone to participate and share fellowship in service to God, take responsibility, and hold positions of spiritual leadership.

Thus, the Hare Krishna movement stands against any form of racial bigotry and discrimination and condemns any behavior that is derogatory, demeaning, and racially insensitive. Instead, it encourages racial harmony and spiritual equality, as did Sri Caitanya Mahaprabhu and Srila Prabhupada. We are committed to creating an environment in which everyone feels valued and is educated to manifest a culture of universal peace, understanding, respect, tolerance, friendliness, and forgiveness. Furthermore, we remain committed to intervening, wherever and whenever necessary within ISKCON, to stop any wrongdoing that opposes such values.

Let us all acknowledge our shared spirituality, transcend racial differences and divides, and together live up to aspirations worthy of our ultimate connectedness with every living being, and with God.

## **Section 400: ISKCON Ministries and Committees**

## 409.01: ISKCON Deity Worship Ministry: Standards

[Title] - Mood of worship — 2021

[Meeting] – Online AGM (passed via GEM on April 17, 2021) [Category] – Statement

Whereas deity worship is an essential element of the process of bhakti and the development of a sadhaka;

Whereas it is intrinsic to a devotee's development in bhakti, and when engaged in deity worship, that a devotee follows the proper rules and regulations governing the worship and understand and follow the appropriate mood of worship;

Whereas devotees who have not attained the platform of spontaneous attachment in devotional service render devotional service under the guidance of a bona fide spiritual master according to the regulative principles mentioned in the revealed scriptures;

Whereas Lord Caitanya explained the mood of worship to Sanatana Goswami as awe and reverence:

sadhu-sanga, nama-kirtana, bhagavata-sravana mathura-vasa, sri-murtira sraddhaya sevana One should associate with devotees, chant the holy name of the Lord, hear Srimad-Bhagavatam, reside at Mathura and worship the Deity with faith and veneration. CC Madhya 22.128

Whereas Srila Prabhupada in his books and other writings, has established the mood of worship for ISKCON temples, most notably in SB 4.24.45-46:

Generally the worship of the Lord begins with the worship of Narayana, or Visnu, whereas the worship of Lord Krsna and Radha is most confidential. Lord Narayana is worshipable by the pancaratrika-vidhi, or regulative principles, whereas Lord Krsna is worshipable by the bhagavata-vidhi. No one can worship the Lord in the bhagavata-vidhi without going through the regulations of the pancaratrika-vidhi. Actually, neophyte devotees worship the Lord according to the pancaratrika-vidhi, or the regulative principles enjoined in the Narada Pancaratra. Radha-Krsna cannot be approached by the neophyte devotees; therefore temple worship according to regulative principles is offered to Laksmi-Narayana. Although there may be a Radha-Krsna vigraha, or form, the worship of the neophyte devotees is acceptable as Laksmi-Narayana worship. Worship according to the pancaratrika-vidhi is called vidhi-marga, and worship according to the bhagavata-vidhi principles is called raga-marga. The principles of raga-marga are especially meant for devotees who are elevated to the Vrndavana platform.

Whereas Srila Prabhupada has explained: The greatest danger to our movement will come when we manufacture and create our own process for worshiping the deities. Letter Jan. 4, 1973;

Whereas deity worship is not a forum for free expression where devotees are able to offer service according to their own idea, but it must be offered according to the direction of guru, sadhu, and sastra;

Whereas Srila Prabhupada established specific standards of deity worship in ISKCON with the mood of awe and reverence being the most central to these standards;

Whereas in recent years we have noticed a steady drift away from this mood of worship established by Srila Prabhupada;

Whereas it is apparent in various temples that this mood of worship is not being followed or has not been understood.

#### **RESOLVED:**

The GBC reaffirms that the mood of worship established by Srila Prabhupada, which is to be followed in all ISKCON centres, is the mood of awe and reverence.

All worship conducted in ISKCON centres, both regular daily worship and occasional worship (such as festivals), must be conducted according to this standard.

All ISKCON leaders are required to ensure that devotees and centres under their care understand and implement worship according to these standards.

As such, all practices that demonstrate a different mood of worship are not approved and must be actively discouraged by leaders at all levels. This includes but is not limited to:

- Devotees' conduct in the presence of the deities
- The way devotees interact with the deities
- The manner in which devotees dress the deities, and
- The different aspects of daily and festival services

## 410: Ministry of Health and Welfare: Dissolution of Ministry

## [Title] - Dissolution of Ministry of Health and Welfare — 2021

[Meeting] – GBC Virtual Meeting (passed on November 24, 2021) [Category] – Action order

#### **RESOLVED:**

That the ISKCON Ministry of Health & Welfare is hereby dissolved.

The GBC Body expresses its gratitude for HH Prahladananda Swami's thirty years of service as the Minister of Health & Welfare.

# 440.01: Vaisnava Memorial Standing Committee [VMSC]: Establishing the committee

## [Title] – Establishing the Vaisnava Memorial Standing Committee [VMSC] — 2021

[Meeting] – GBC Virtual Meeting (passed on May 19, 2021) [Category] – Administrative order

Whereas the GBC affirms there is a need to have standard policy on the establishment of Vaisnava memorials and who is eligible for what type of memorial;

Whereas the GBC deems this is a task that should be overseen by a committee and therefore, at the 2008 AGM, passed the following Resolution:

That the standing Commemoration Committee is established with the mandate as follows:

- 1. To research and establish a standard set of guidelines documenting the process for correctly honoring departed Vaisnavas.
- 2. To maintain records of departed ISKCON Vaisnavas and a summary of their services for the society.
- 3. To determine the application of the guidelines in individual cases.
- 4. To decide which of the departed disciples of Srila Prabhupada will be interred in full, given a puspa samadhi, or honored with a plaque in the Mayapur Garden of Inspiration.

Praghosa dasa (convenor), Bhakti Caru Swami, Bhakti Purusottama Swami, and Mahamaya devi dasi are assigned to the standing committee.

Whereas this committee was never active;

Whereas the committee's focus is to establish guidelines for, and approval for Vaisnavas who may be remembered in memorial parks, Vaisnava Memorial Standing Committee (VMSC), is a more appropriate name;

Whereas, as the devotee population ages, an increasing number of devotees are passing away and the need to establish a universal policy for Vaisnava memorials is ever more pressing.

### **RESOLVED:**

That the GBC re-establishes the Commemoration Standing Committee and renames it the Vaisnava Memorial Standing Committee. The mandate or scope of the Vaisnava Memorial Standing Committee will be as follows:

- 1. To research and establish a standard, global policy for appropriately honoring departed devotees. Such a policy will take into account, and reflect the global diversity of ISKCON, and shall duly respect the contribution of Vaisnavas as well as Vaisnavis.
- 2. To proactively reach out to all sannyasis, gurus, GBCs and other senior devotees to establish what they want done with their bodies or remains after their passing away, either by obtaining a copy of their will and testament, or by their own written statement, and:
  - a. Establish and maintain a list of devotees who are eligible for samadhi, either full body or other:
  - b. Decide how departed devotees will be honored;
  - c. Determine what standard size of memorial is appropriate for all departed devotees;
  - d. Identify exceptional cases and refer them to the GBC body.
- 3. To communicate with regional bodies and temples, looking for recommendations for candidates for samadhi.
- 4. To maintain records of departed devotees and a summary of their services for ISKCON, and to make this information readily available to the members of ISKCON, through a website, and/or other suitable means.

# 440.02: Vaiṣṇava Memorial Standing Committee (VMSC): Regulations

### [Title] - Types Of Memorials For Departed Vaisnavas — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

Whereas of the 27 GBC members who voted on this topic, 23 members voted for a plaque, a structure, or both.

### **RESOLVED:**

That Vaiṣṇavas being recognized in the Memorial Park may have one of the following:

- 1. A plaque established on the Remembrance Wall
- 2. A small ash samadhi (a plinth with their name on it)
- 3. A small puspa samadhi (a plinth with their name on it)
- 4. A full body samadhi with a samadhi structure

# 440.02: Vaisnava Memorial Standing Committee (VMSC): Regulations

## [Title] - Samadhis for Sannyasis — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement Whereas the GBC Samadhi Committee has presented evidence that sannyasis are generally buried;

Whereas it is not essential that a 'samadhi structure' be erected over the body of a departed sannyasi. Instead a tulasi plant or a tree could be planted over their body;

Whereas of the 21 GBC members that voted on the question "Should Sannyasis automatically get a vapu samadhi?" 16 voted against;

Whereas of the 45 sannyasis that responded to a SABHA survey on samadhis, 22 said they did not want their bodies put in samadhi;

Whereas Srila Prabhupada said 'Anyone who is in full Krishna Consciousness and is dedicating his life for Krishna is already a sannyasi even if he is a married man.'

### **RESOLVED:**

That although sannyasis are usually buried, it is not essential this must be done nor is it essential that a samadhi structure be erected for every sannyasi.

# 440.02: Vaisnava Memorial Standing Committee (VMSC): Regulations

### [Title] - Location of Vaisnava Memorial Park in Sri Mayapur Dhama — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

Whereas a number of GBC members expressed reservations about establishing future memorials in the location next to Srila Prabhupada's Puspa Samadhi in Sridham Mayapur.

Whereas there is a need to have a memorial park for Vaisnavas in Mayapur.

### **RESOLVED:**

That the general location for future samadhis for the majority of devotees shall be near the Jagannath Mandir in Simantadvipa.

At this location devotees may be honored in the following ways:

Their full body is placed in the ground, with either a samadhi structure, a plinth with a plaque, or a tree above:

Puspa or ash samadhis, with either a samadhi structure, a plinth with a plaque, or a tree above;

A memorial wall or other structure for memorial plaques;

A kiosk where devotees visiting the memorial park may learn about departed ISKCON devotees.

# 440.02: Vaisnava Memorial Standing Committee (VMSC): Regulations

### [Title] - Vaisnava memorial wall in Sri Mayapur Dham — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

Whereas an important element of Vaiṣṇava memorials is a memorial wall with plaques where visiting devotees may remember departed ISKCON devotees and reflect on their service to Lord Kṛṣṇa, Srila Prabhupada, and the guru parampara;

Whereas the GBC body agreed there should be a memorial wall in Sri Mayapur Dham;

Whereas the GBC body expressed their desire not to overdevelop the area next to Srila Prabhupada's puspa-samadhi in Sri Mayapur Dham;

Whereas there are other suitable locations where a memorial wall may be located.

#### **RESOLVED:**

That there may be more than one memorial wall in Mayapur. The first memorial wall will be located on the inside wall of the ground floor or first floor of Srila Prabhupada's puspa-samadhi, to be finalised in discussion with Mayapur Management. A second Memorial Wall could be located at the Jagannath Mandir Vaiṣṇava Memorial Park as required.

Wherever memorial walls are located there will also be a kiosk where visiting devotees can access information about the departed ISKCON devotees.

# 440.02: Vaisnava Memorial Standing Committee (VMSC): Regulations

### [Title] – Worship at Vaisnava samadhis — 2020

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

Whereas at present there is daily worship going on at Srila Prabhupada's Puspa Samadhi;

Whereas the worship at other existing samadhis is going on at different levels depending on the disciples of the devotee(s) involved;

Whereas of the 21 GBC members that voted in the survey, 13 GBC members opted for no daily worship at the individual samadhis;

Whereas ISKCON Law 701.05, "Guru Worship Standards —2009" amends ISKCON Law 6.4.8.1.3 to the following:

D. In order to focus more fully on Srila Prabhupada and every devotee's special relationship with him, an ISKCON siksa or diksa guru may accept public guru puja (arati and/or foot bathing) in person once a year on ISKCON property on his or her Vyasa-puja.

### **RESOLVED:**

1. No daily worship, either individual or collective, is required to be offered to any Vaiṣṇava in any Vaiṣṇava Memorial Park in Mayapur. However, individuals may occasionally offer incense, flowers, or prasadam remnants.

- 2. A modest ceremony honoring a departed Vaiṣṇava may be organized on the appearance and disappearance days of the departed Vaiṣṇava. This function may include offering bhoga, arati, puspanjali, glorification of the departed Vaiṣṇava, and a feast.
- 3. In accordance with existing ISKCON Law there will be no *murti* (deity) of any departed Vaiṣṇava. There may be a photo of the departed Vaiṣṇava and where applicable a pair of shoes or other similar paraphernalia.
- 4. This resolution is retroactive and applies to all existing samadhis located anywhere on ISKCON land in Mayapur.

# 440.02: Vaisnava Memorial Standing Committee (VMSC): Regulations

## [Title] – GBC direction to Mayapur leadership regarding further samadhi area in Mayapur — 2021

[Meeting] – Online AGM (passed on February 10, 2021) [Category] – Statement

### **RESOLVED:**

That, the GBC hereby directs the Mayapur leadership to identify land near the Jagannath Mandir that can be used as a second location for samadhis, and to make whatever preliminary, minimum arrangements are required.

## 451.02: Prevention of Leadership Misconduct Office

## [Title] -Polices and procedures for the PLM office— 2021

[Meeting] – Online AGM (passed on March 31, 2021) [Category] – Statement

Whereas in 2018 it was resolved that the ISKCON International Office for the Prevention of Leader Misconduct (PLM Office) be established as a permanent ISKCON organizational entity subject to annual review by the GBC Body (as with other Offices and Ministries);

Whereas the immediate goal of the PLM Office was to draft a document of ISKCON International Policies and Procedures.

### **RESOLVED:**

The document entitled <u>International Policy and Procedure Guidelines</u> is hereby adopted as ISKCON's official policies on:

- (a) preventing Leader Sexual Misconduct
- (b) responding to complaints and
- (c) conducting investigations into allegations of sexual misconduct by leaders in ISKCON and resultant disciplinary proceedings.

## 453.03: Sastric Advisory Council: Papers

## [Title] – Sastric Advisory Council's Hermeneutic Foundation Document — 2020

[Meeting] – AGM 2020 (passed on February 17, 2020, not published then by oversight) [Category] – Statement

### **RESOLVED:**

The GBC acknowledges the <u>SAC Hermeneutic Foundation Document</u> as the basis for starting hermeneutic training in ISKCON and acknowledges the SAC Hermeneutic Supplementary Materials as a useful guide to the Foundation Document. Others may produce their own guides to the Foundation Document.

The SAC has produced a level one training course based on these materials that may be of value to ISKCON members.

## Section 700: Gurus and disciples

## 701.02: ISKCON spiritual masters: Approval and regulations

[Title] - Initiating in the presence of one's guru: Amendment — 2021

[Meeting] – Online AGM (passed via GEM on June 8, 2021) [Category] – Governing law

Whereas there is a need to increase the number of diksa gurus in ISKCON which will necessarily include:

- 1) requesting and training qualified second generation devotees whose diksa-gurus are no longer physically with us (or in good standing), to take up the service of diksa-guru immediately
- 2) requesting present diksa-gurus to identify, train, and empower qualified disciples to accept the service of offering diksa initiation, even while they are still present.

Whereas it can be clearly observed that whenever Srila Prabhupada spoke about disciples not initiating in the presence of their guru he always referred to it as etiquette.

Whereas on 2 December, 1975 Srila Prabhupada wrote to Tusta Krishna Swami and used the phrase "law of disciplic succession" in the following manner: "Keep trained up very rigidly and then you are bona fide Guru, and you can accept disciples on the same principle. But as a matter of etiquette it is the custom that during the lifetime of your Spiritual master you bring the prospective disciples to him, and in his absence or disappearance you can accept disciples without any limitation. This is the law of disciplic succession".

Whereas even in the one letter where he used the phrase "law of disciplic succession", it is important to observe that he continued to use the same term etiquette while referring to disciples not initiating in the presence of their guru.

Whereas considering Srila Prabhupada's consistent and overwhelming use of the phrase "etiquette" without exception including the letter where he wrote about the "law of disciplic succession", the said letter should be seen in the same context of etiquette rather than something distinct.

Whereas we have precedents in our parampara like Srila Syamananda Pandita who authorised his disciple Sri Rasikananda Prabhu to accept disciples in his physical presence but did not stop initiating himself. Srila Bhaktisiddhanta Sarasvati Thakura was also requested to initiate in the presence of his guru(s) and Srila Bhaktivinoda Thakura gave initiation even while Vipina-Bihari Goswami and Jagannatha dasa Babaji were present.

Whereas Srila Prabhupada was present with us for only a brief period of twelve years. It was natural that in such a short span of twelve years he was insistent about the etiquette of his disciples not initiating in his physical presence.

Whereas the current situation is vastly different from the 12 years of Srila Prabhupada's physical presence with us, borne by the fact that some disciples of presently initiating gurus have been in the movement for more than 40 years.

Whereas if a guru were to recommend such long serving disciples to start initiating, then it should be accepted as applying a precedent from our parampara according to time, place, and circumstances.

Whereas to facilitate devotees to serve as diksa-gurus while their own gurus are physically present, is currently a bureaucratic and time-consuming process due to the 2019 amendment of GBC Law 7.3.2.

### **RESOLVED:**

That ISKCON Law 7.3.2 reverts to its previous formulation thus:

"As taught by Srila Prabhupada, the etiquette of not initiating in the presence of one's *diksa-guru* will be upheld in ISKCON. However, Srila Prabhupada and historical precedents also teach us that disciples may sometimes initiate in the physical presence of their *diksa-gurus*, if so directed by them. In such a case, the disciple should go through the normal procedure for commencing the service of *diksa-guru* (7.4.1)."

### [Footnotes to resolution]

The 2019 amendment being repealed by this resolution is as follows:

### Section 700: Gurus and Disciples

701.2 ISKCON Spiritual Masters Conditions for Second-generation Diksa-gurus — 2019 [Governing law]

Whereas ISKCON Law 7.3.2 now reads: "As taught by Srila Prabhupada, the etiquette of not initiating in the presence of one's diksa-guru will be upheld in ISKCON. However, Srila Prabhupada and historical precedents also teach us that disciples may sometimes initiate in the physical presence of their diksa-gurus, if so directed by them. In such a case, the disciple should go through the normal procedure for commencing the service of diksa-guru (7.4.1)."

Resolved: ISKCON Law 7.3.2 is amended to read as follows:

As taught by Srila Prabhupada, the etiquette of not initiating in the presence of one's diksa-guru will be upheld in ISKCON. However historical precedents also teach us that disciples may sometimes, in exceptional cases, initiate in the physical presence of their diksa-gurus.

The GBC clarifies that an individual devotee taking up the service of diksa-guru in the physical presence of their guru may be allowed as an exception when the following conditions are met. The Guru Services Committee will confirm that the candidate for becoming a second generation guru has met all these conditions:

Mandatory Conditions:

- 1. The candidate must have been practicing Krishna consciousness for not less than 25 years
- 2. The candidate's diksa-guru has affirmed in writing to the GBC Body that he agrees the candidate is suitable for this service and that he gives his blessings.
- 3. A letter of approval for the candidate to take up the role of diksa-guru has been received from the Regional Council, or if none exists, the National Council, Area Council or, if none of the above exists, the GBC member of that area where the candidate primarily serves or resides.
- 4. All standard procedures for commencing the service of diksa-guru according to ISKCON law, including required training and other conditions, as well as additional appropriate training from diksa- and/or siksa- gurus, have been met.
- 5. Final acceptance of the candidate to begin initiating is affirmed by a ¾ vote of the GBC Body. Additional Mandatory Condition (may be waived by a ¾ vote of the GBC Body): The candidate's own diksa-guru has to retire completely from accepting disciples, or agree to

immediately retire upon acceptance of the candidate to accept his own disciples. Factors to be considered by the GBC in determining if a waiver may be approved:

- The area in which the candidate will initiate has a substantial number of devotees wanting initiation, and a shortage of gurus to do this service. Language barriers necessitate gurus who speak the local language in a specific area(s).
- The currently initiating guru is overburdened with responsibilities.
- The currently initiating guru is experiencing serious health problems.
- Optional conditions that may be applied in an individual case, per a ¾ vote of the GBC:
- When the candidate takes up the service of diksa-guru he will only be able initiate in a specific area(s).
- The number of disciples the new diksa-guru may initiate can be limited by the GBC.
   The GBC Guru Services Committee shall develop a more detailed process to implement the above resolution. This process will come for final review by the GBC Body.

## 701.03: ISKCON spiritual masters: Qualifications and training

## [Title] – Educational Program for those who serve as Diksa- and Siksa-gurus in ISKCON — 2021

[Meeting] – Online AGM (passed via GEM on July 19, 2021) [Category] – Statement

Whereas Srila Prabhupada repeatedly called upon his disciples and followers to qualify themselves as spiritual masters to propagate Lord Caitanya's mission worldwide;

Whereas Srila Prabhupada also wanted the spiritual masters to be qualified, which requires training based on his teachings;

Whereas Srila Prabhupada made giving and receiving sikṣa the primary function of ISKCON, and whereas we as his followers should endeavor to enhance and improve this function;

Whereas developing such a systematic guru training program can easily avail itself of existing educational initiatives.

Whereas the rapid international growth of ISKCON necessitates a proportionate increase in the number of competent spiritual masters.

Whereas this initiative follows in the footsteps of a number of GBC resolutions seeking to address this requirement.

### **RESOLVED:**

That the Governing Body Commission of the International Society for Krishna Consciousness accepts and supports the following principles for preparing devotees to act in the role of gurus:

All devotees, especially after taking second initiation, are encouraged to undergo systematic training to become qualified to act as spiritual preceptors.

The program shall include but not be limited to:

- demonstrating sastric knowledge (including but not limited to *Bhagavad-gita*, *Nectar of Devotion*, *Srimad-Bhagavatam* and *Caitanya-caritamrta*);
- learning about Srila Prabhupada's biography and position;
- assimilating the proper codes of personal behavior (Vaiṣṇava sad-acara);
- training on balancing life's priorities and obligations;
- how to serve harmoniously within ISKCON;
- relevant ISKCON legislation;

- emphasis on loyalty to Srila Prabhupada, ISKCON and the GBC;
- instruction on how to guide and counsel siksa- and diksa-disciples;
- · personal mentorship of candidates; and
- considerations for regional variations.

To facilitate participation and completion, the training program shall be self-paced and include a blend of online and in-person training.

The Guru Services Committee, the GBC College for Leadership Development and the ISKCON Board of Examinations, shall collaborate in drafting and defining the curriculum, which shall be submitted to the GBC for approval before implementation. The curriculum shall include ongoing training and support for those serving as siksa- and diksa-gurus.

After an interim period — the length and parameters of which shall be defined separately — such a training program shall become a mandatory prerequisite for commencing the service of an initiating spiritual master.

## 701.06: ISKCON spiritual masters: Vaisnavi Diksa-gurus

[Title] - Vaisnavi diksa-gurus — 2019: Amendment — 2021

[Meeting] – GBC Virtual Meeting (passed on December 22, 2021) [Category] – Governing law

Whereas the GBC put in abeyance the 2019 Vaishnavi Diksa Guru resolution so that the GBC and the Indian Bureau could discuss the topic in more detail,

Whereas representatives of the Bureau and representatives of the GBC met jointly more than two dozen times over the period of a year,

Whereas those meetings were facilitated by professional mediators, including a mediator chosen by the Bureau, and another mediator who is a senior member of ISKCONResolve,

Whereas the GBC representatives made a sincere effort to hear and understand the concerns and opinions of the Bureau representatives,

Whereas the GBC representatives noted that they valued the time spent with the Bureau members, and that they now better understand the views of the Bureau representatives after those meetings,

Whereas the GBC delegation concluded that further meetings, or additional study of the matter, would not provide new insights,

Whereas the GBC delegation reported that, based on these discussions, some clarifications of the 2019 Resolution on Vaishnavi Diksa Gurus are required, 701.6, "ISKCON Spiritual Masters, Vaisnavi Diksagurus—2019.

Whereas the GBC, in its November 17, 2021, meeting, determined that on rare occasions a GBC Resolution may be certified as a Culturally Sensitive Resolution, and thus, within specific GBC guidelines, that Resolution may be applied differently across ISKCON regions,

Whereas in 2009 the GBC Resolved (Female Diksa Gurus):

The GBC accepts the philosophical conclusion presented in the SAC's Female Diksa Guru Paper that a mature, qualified, female devotee may accept the role of an initiating spiritual master.

The GBC Body authorizes local area committees to put forward for approval as initiating guru any devotee in their area, male or female, who is qualified according to existing GBC Law.

Whereas, the GBC has worked to achieve consensus and implementation of this resolution for many years, including the above mentioned extensive dialogues with representatives of the India Bureau;

Therefore, the Resolution regarding Vaisnavi Diksa Gurus of 2019, 701.6, "ISKCON Spiritual Masters, Vaisnavi Diksa-gurus—2019 is amended and replaced by the following:

- 1. Vaisnavis are eligible to give diksa within ISKCON provided that they:
  - a. Meet all the qualifications listed for ISKCON diksa-guru applicants;
  - b. Are at least 55 years of age.
  - c. Are in a stable family situation living under the protection of a husband, elder son or son-in-law, qualified householder couple or senior Vaisnava or Vaisnavi sanga;
- 2. After five years the GBC shall review this resolution to determine if the number of Vaisnavis initiating in any region, or as a total for the world, is in keeping with Srila Prabhupada's indication of "not so many."

**Prof. O'Connell:** Is it possible, Swamiji, for a woman to be a *guru* in the line of disciplic succession? **Prabhupada:** Yes. Jahnava devi was---Nityananda's wife. She became. If she is able to go to the highest perfection of life, why it is not possible to become *guru?* But, not so many. Actually one who has attained the perfection, she can become *guru*. But man or woman, unless one has attained the perfection... *Yei kṛṣṇa-tattva-vettā sei guru haya* [Cc. Madhya 8.128].

3. Furthermore, this resolution is designated as a "Culturally Sensitive Resolution." Per GBC law:

A Regional Governing Body (RGB), or where there is no RGB, an authorized national council with the support of their GBC, or where a national council has more than one GBC, a majority of their GBCs, may apply to the GBC Body with a request to modify a culturally sensitive resolution for their area/yatra. Such a request must include the details of the specific adjustment/s they propose to make, as well as the reasons for requesting such an adjustment/s.

The GBC Body will give guidelines and set out the parameters regarding what may or may not be adjusted within a culturally sensitive resolution.... Any details, guidelines, parameters, timelines, etc., in regard to its exceptional status must be recorded within the resolution itself.

Thus, by designating this as a Culturally Sensitive Resolution, the GBC hereby establishes that an RGB or other authorized ISKCON leadership body as denoted in the above referenced law—<u>may opt out</u> of this mandate and choose <u>to not allow</u> any Vaisnavis to initiate within their jurisdiction. Any given RGB that does *not* opt out and proceeds to fully implement this resolution, may, at their discretion, allow any given country within their region to opt out of applying this resolution. Naturally that would only be done after very careful consideration, as the default position is to always fully implement GBC resolutions.

In those regions or countries that choose to opt out, if a particular candidate for diksa guru is approved by a special 2/3 vote of that RGB, or other authorized body, per above, then she shall be accepted as a diksa guru in that region or country.

A decision to opt out must be reaffirmed by that RGB, or authorized body per above, every five years. No other adjustments to this resolution are authorized or will be permitted.

This resolution lifts the abeyance on this matter stated in resolution 310 of 2015.

## 702.02: Diksa-gurus

### [Title] - Increasing the Number of Diksa-gurus - 2021

[Meeting] – Online AGM (passed on July 29, 2021) [Category] – Statement

Whereas connection via *diksa* to the *parampara* is essential for anyone aspiring to advance in Krishna consciousness.

Whereas ISKCON needs a sufficient number of initiated devotees to perform many essential services, which can only be performed by properly initiated devotees

Whereas ISKCON still has a similar number of *diksa-gurus* as at the end of the 1980s (+/- 80), while the number of aspiring devotees in ISKCON has increased at least fiftyfold or more since then; thus an acute lack of *diksa-gurus* has become an ever growing problem to facilitate the increased number of persons now engaged in devotional service

Whereas the present generation of *diksa-gurus* will be drastically reduced within the next decade or so. Thus a new generation of *diksa-gurus* urgently needs to be established in ISKCON

Whereas ISKCON's demography has changed from ashrama living to largely being a movement of congregational devotees centred around communities; there is an increasing need of a more natural and organic diksa-guru culture in line with Srila Prabhupada's statement in CC. Adi 1.35 purport: "Generally a spiritual master who constantly instructs a disciple in spiritual science becomes his initiating spiritual master."

Whereas we can observe – for different reasons - a clear change in the social culture of the world and therefore cannot take it for granted that smooth travel all over the world will be possible in the future; thus an increasing number of more locally accessible *diksa-gurus*, each having a moderate number of disciples will be more sustainable and will strengthen our preaching movement as a whole, as well as local preaching projects.

Whereas a considerable number of the local "spiritual masters who constantly instruct their disciples in spiritual science" are often not disciples of *diksa-gurus* who have left this world.

### **RESOLVED:**

The GBC hereby states their commitment to increase the number of *diksa-gurus* in ISKCON by systematically and promptly increasing the number of *diksa-gurus* before we lose the present gurus. The GBC also accepts the principle that the number of *diksa-gurus* must reflect, as closely as possible, the actual size of ISKCON, and that the future system leans to having many local *diksa-gurus* with fewer disciples, rather than having a limited number of international gurus with many disciples. Furthermore, the GBC members will support and promote prominent *siksa-gurus* initiating while their *diksa-gurus* are present.

The GBC will support programs that facilitate more *diksa-gurus* while the present *diksa-gurus* are with us.
